Privacy Policy

1. Use of this Website

1.1 North Harbour Hire Limited (NHH), (We or North Harbour Hire, NHH) is committed to protecting and respecting your privacy.

1.2 Your access to and use of this Website (www.nhhire.co.nz) and its contents (Website) is subject to the terms and conditions of this Privacy Policy (Privacy Policy), NHH's Terms of Trade posted on this Website (Terms of Trade), any documents referred to in the Terms of Trade or otherwise on this Website and all applicable laws.

1.3 By accessing and using this Website, you (User or you) accept and agree without limitation or qualification, to the terms and conditions contained in this Privacy Policy, the Terms of Trade, any other relevant documents referred to in the Terms of Trade or otherwise on this Website and all applicable laws. For the avoidance of doubt, 'using this Website' includes access to, browsing of, reviewing, posting of, transmitting, downloading, and any other means of using the Website or any material on the Website.

2. Collection of your personal information

information held by it about its customers will be one of the transferred assets.

4.2.3 If we are under a duty to disclose or share your personal information in order to comply with any legal obligation, or in order to enforce or apply our Terms of Trade and other agreements, or to protect the rights, property or safety of NHH, our customers or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

4.3 We may also use your personal information or permit selected third parties to use your personal information to provide you with information about goods and services which may be of interest to you and we or they may contact you about these goods or services.
